LETTER FROM THE CHAIRMAN



Spring approaches and for the many aviators who hibernate in the winter, myself included, now is the time for 'annuals' on our aircraft, checking all the kit and a spring clean. INTERNATIONAL COMPETITIONS and AWARDS

John Williams was the winner of the Bitterwasser Cup for 2011. This award is presented to the glider pilot with the best score for six European sprint flights over a two-year period in the International Gliding Commission On-line Contest. John flew four flights at over 180 kph and two at over 170 kph, to take the award by a comfortable margin.

Team Gringo took third place in the Rookie category at the finals of the European Skydiving League, which took place in September at Texel in the Netherlands.

David Hempleman-Adams and **Jon Mason** won the America's Challenge Gas Balloon Race, with a flight from Albuquerque to the Canadian border. As with the Gordon Bennett Cup, the longest distance flight wins. David and Jon completed 1538 km over 71 hours, beating their nearest rivals by just 44 km.

David Bareford took the Bronze medal in the European hot-air ballooning Championships held at Lleida in Spain. The competition involved twenty-one tasks, in seven flights, which took place over a week in September.

WORLD and EUROPEAN RECORDS

Eighteen British skydivers took part in a new European record, an 80-way free-fly head-down formation. The record was set in Spain.

Belated congratulations to Norman Surplus, for his World Records last July, with a speed of 127.9 kph for a flight from Laoag in the Philippines to Okinawa in Japan and also for his journey from Larne in Northern Ireland to Oki in Japan, achieved at a record speed of 0.79 kph. Norman was flying a rotorcraft powered by a Rotax 914 engine.

Britannia Trophy

Dave Sykes - Nominated by BMAA



Dave Sykes, a paraplegic who broke his back in a motorbike accident 18 years ago, has been awarded the trophy for his solo, record breaking microlight journey from York to Sydney. The flight passed through 19 different countries over hostile terrain, long sea crossings and deserts, while also encountering testing meteorological conditions on the way. He had to cope with dust storms over Saudi Arabia, was threatened with being shot down over Iran and only just survived a huge storm above Burma. The flight took four months, between April and August 2011, and covered over 23,000 km and 277 hrs of flying.

SAFETY

Strasser Scheme

Carlisle Airport is the 207th airport to join the Strasser scheme. Only five airports (Belfast, Cardiff, Leeds-Bradford, Luton, Manchester) are now refusing to join the scheme, in addition to Heathrow, Gatwick and London City, who have not been approached.

CAA GA Safety Award

The British Gliding Association's Safe Winch Launch Initiative Team, led by Hugh Browning, won the 2011 General Aviation Safety Award. The

initiative, which has been running for six years, has dramatically reduced the number of fatal gliding accidents.

FAI NEWS

Amateur Built and Experimental Aircraft

The Commission for Amateur Built and Experimental Aircraft (CIACA) has been transferred from the designation of a Technical Commission to an Airsport Commission. For a trial period, World Record claims may now be submitted through the LAA, rather than through the Records Racing and Rally Association.

FAI Senior Sports Manager

Rob Hughes, the immediate past Chairman of the British Microlight Aircraft Association, has been appointed as the new FAI Senior Sports Manager. Rob previously worked for the FAI in 2008/09 as General Projects Manager, with responsibility in particular for the World Air Games 2009.

Safety in Competitions

Following fatal accidents at the paragliding World Championships last year, the FAI Executive Board considered the circumstances in which any event held under the FAI Sporting Code may be cancelled or terminated by the FAI. As the Sporting Code did not cover the circumstances which occurred in 2011, the Executive Board has issued a statement to take immediate effect, that events may be cancelled for reasons of force majeure, substantial risks to the safety of participants, major financial uncertainty regarding the viability of the event, or other reasons that may arise from time to time.

An appropriate amendment is to be made to the Sporting Code General Section to reflect this decision-making process.

Harmonised Transition Altitude Consultation

The CAA launched a formal consultation on 31 January 2012 with UK aviation stakeholders on the policy to introduce a harmonised transition altitude of 18,000 ft in the London and Scottish Flight Information Regions. RAeC and GA Alliance activity

At the recent RAeC Council meeting, Roger Hopkinson provided a briefing relating to his activities as Chairman of the General Aviation Strategic Forum, which includes representation from the DfT and CAA. Roger outlined the 'Strategic Importance Document' he had produced to help ensure that parliamentary resolutions were progressed. The document addressed a wide range of issues including the adverse impact of EU regulation, a review of recreational aviation, the Civil Aviation Bill (and any unintended consequences), future airspace strategy, aerodromes airfields and landing strips, the safety plan, concern over declining UK based training and the future of fuels. There is to be a meeting with the DfT and CAA to develop action plans to address the issues.
