### 2: Sites Database

For Sites Officer/CFI.

The rationale behind the BHPA Sites Database is described in the BHPA Tech Manual para 1.3.15 and Appendix A. In simple terms we seek to have a single Resident Club/School for every site. This single point of contact will co-ordinate site information on behalf of all authorised users, and act as a focal point for enquiries whether they be from members, clubs, landowners, other users, or on matters of airspace.

We are making progress on updating the database. To that end every Club/School has recently (Nov 15) been sent a validation report detailing of all sites for which they are listed as Resident. The idea is that we can check and amend the details held.

If you haven't received a validation report it could be for a number of reasons:

- No sites registered (non-area based clubs like the military).
- Shared sites. Reports have only been sent to Resident Clubs/Schools. If you are a user and you think you know who is Resident please check the arrangement with them in the first instance.
- Any other reason.

If you don't know who is Resident (or think that it should be you) then please let us know.

In a new initiative we maintain a record of closed sites. By maintaining a brief history of why a site is no longer used (safety, landowner, etc) we can answer enquiries from enthusiastic new pilots, avoid repeating the mistakes of the past, and minimise further aggravation for landowners.

If you have any questions or concerns Stef, in the BHPA office, is your first point of contact. My email address is in Skywings, although I suspect that I will be up to my neck in site disputes by the time you read this!

### 6: Pilots Using Speed Flying Or Mini Wings

The majority of speed wings (and some mini wings) are uncertified. This means they do not have an independent verification of airworthiness, for example EN 926-2 Flight safety characteristics certification (although some speed wings have been load tested in accordance with EN 926-1).

If your wing does not have a flight safety characteristics certification, e.g. EN-A, EN-B, etc, the BHPA requires a Pilot's Declaration to be completed so that you can be registered on the system as a pilot of an uncertified wing.
