## ITEM 4: PUBLIC FORUM

It was agreed that the Facebook page would be kept as a source of announcements and as a signpost to the website, however commenting would be removed.

## ITEM 5: MEMBER M

A discussion was held re the suitability of renewing Member M's membership.

## ITEM 6: REPORTS

#### 6.1 Finance

- 6.1.1 Angus Langford reported that for the year ended 31st March 2020 we reported a loss of £19K. This was worse than expected but was due to a fall-off in membership.
- 6.1.2 Angus had circulated a report showing the suspected impact on finances from the coronavirus lockdown. Although April and May's accounts are showing a small surplus it is expected we will have a substantial loss by the end of the year.
- 6.1.3 Marc Asquith commented that the statistics graph took a sharp nosedive at the beginning of lockdown but had now started to stabilize. The general consensus was that there was a huge amount of interest in leisure pursuits which should be capitalised on.

## FOR ACTION: (2020 – B3) Bill Bell to write an article for the website.

6.1.4 Marc Asquith explained that it was necessary to keep staff furloughed at present, but this would be reviewed regularly.

#### **6.2 FSC**

- 6.2.1 Angus Pinkerton thanked Mark Shaw for all his hard work.
- 6.2.2 Angus reported that the resumption of flying had already resulted in a couple of incidents.
- 6.2.3 There have been concerns over the future of our schools so Mark Shaw spoke to the majority of them during May. Most were understanding of the situation and were managing. We do need to get them up and running as soon as possible. Currently we are waiting for a relaxation in the rules so group sizes can be increased.
- 6.2.4 We have a new hang gliding school on board who would like to train ab-initio. At present we are unable to travel to complete the usual instructor training. Alternative approaches are being considered.
- 6.2.5 Angus reported that there have been better relations with the CAA since lockdown. There have been meetings regarding electronic conspicuity for which the CAA are looking to subsidise equipment. Any grants for hang gliding and paragliding will only be available to BHPA members.

#### 6.3 Insurance

Martin Heywood reported that things are quiet.

Marc Asquith commented that he expects the Wayne Seeley incident will result in a claim from the power company.

Martin Baxter's report had been circulated.

Paul Dancey's report had been circulated.

#### 6.6 Website

Paul Dancey reported on the new online application form and renewal system he has developed. It has had a fairly low-key launch but has already received much use.

Bill Bell reported that there has not been any competition, it will be some time before any are planned.

Marc Asquith reported that the RAeC have an online meeting planned.

#### 6.9 School Liaison

John Welch reported that most schools remain up-beat. They are receiving plenty of enquires, many of which are from new students.

#### 6.10 Paramotor Liaison

Tom Prideaux-Brune asked if it was possible for the association to obtain more sites for paramotorists to use. Ed Cunliffe explained that we do not own any sites, although some clubs do. Most pilots obtain permission from local farmers to use their land. Martin Heywood also commented that many small airfields are happy for paramotorists to use them.
