Update to 2021 – B7 Angus Langford has been working with the office to draw up a requirements document. He is considering where the Association wants to be in ten years' time. He has also had initial discussions with Kantala, who support our current database, about how we can work on making it more current.

Update to 2021-C2 lan Currer had contacted the Paragliding Association of India to inform them of the costs of running a course for them. They are still interested although it is likely it will be 2023 before we will be in a position to go ahead with it.

ITEM 6: HARDCOPY SKYWINGS

Martin Baxter had circulated a paper about Skywings prior to the meeting. He was keen to understand the reasons behind continuing with a hard copy versus running an online copy only. Members are likely to query this point and we should have a good justification for our decision.

It was noted that whilst the younger generation prefer to read things online many other members see the magazine as a way of 'switching off' and taking time away from a screen. It was perceived that although the time will come for an online only magazine this is still some distance in the future. It will need considerable investment and will employ a whole different skill set. In the absence of dramatic changes, it was agreed that this matter would be revisited in five years' time.

ITEM 7: FLYABILITY FUNDING

A Flyability report had been circulated to Exec prior to the meeting.

It was agreed that as their finances are healthy regular BHPA funding should be suspended. If they need help with specific projects, they can approach us for funding at the time.

ITEM: 8: CLUB SITES - 28 DAY RULE

The Local Planning Authority is enforcing the rule that limits Challow Paramotoring Club to using it's site (on agricultural land) for 28 days per year. There was a relaxation of this rule, during Covid 19, that allowed farmers to use their land for other uses for up to 56 days, this expired in December 2021.

A Worcestershire farmer, supported by the NFU, is lobbying to get a further extension as a means of rural income diversification for farmers. Francis Rich is asking for our support to do the same. Francis typically operates between 38 to 48 days per year, so this restriction greatly impacts Challow Paramotoring Club's operation.

After discussion it was agreed that although we are sympathetic with Francis raising this as a national issue could generate more negatives than positives for the sport. Paramotoring already attracts a lot of negative press and raising our profile would not improve this.

It was agreed that the best route would be for Francis to take legal advice and to pursue the 10-year rule (if you've been doing something for 10 years you can challenge any enforcement).

FOR ACTION: (2022 – A3) Martin Baxter to communicate the Exec's decision regarding the '28-day rule' to Francis Rich.

ITEM: 9: NATIONAL TRUST – FLYING BANNED DURING BREEDING SEASON

Martin Baxter had been contacted by Graham Phipps regarding an email received from his local National Trust Warden. This advised that following advice from Natural England they have banned flying during the breeding season (February – September) at two existing sites within the SSSI. Graham was asking for advice on how to challenge the matter.

Martin commented that other clubs have contacted him to say they have resolved this issue on a local level and were keen to keep things low key and not 'rock the boat'.

Marc Asquith had been approached by the BMFA over jointly challenging the National Trust's decision.

After discussion it was agreed that the matter should be kept as a local issue initially. The first step would be for the club to approach Natural England and ask for the rationale behind their decision.

FOR ACTION: (2022 – A4) Martin Baxter to notify Graham Phipps that he should contact Natural England and ask for their rationale behind the decision to ban flying on SSSI sites during the breeding season.

FOR ACTION: (2022 – A5) Marc Asquith to inform the BMFA of our decision re the National Trust's ban on flying during the breeding season
